DEAR MR HADDON,

AS PER THE AGREEMENT HERE IS THE PRELIMINARY REPORT THAT I WILL BE SENDING BACK VIA THE SHIP.

TO DATE THE WATCH HAS BEEN SUBJECTED TO SEVERE MOVEMENT AND SHOCK WHILE WORKING IN MINUS TEMPERATURES OFF LOADING STORES AND SUPPLIES. I HAVE ON OCCASIONS SUBJECTED THE WATCH TO CONTINUOUS SHOCK AND VIBRATION WHILE DIGGING ARTICLES OUT OF THE ICE (EG. THE USE OF POWER JACK HAMMERS)

THE COLDEST TEMPERATURE THAT THE WATCH HAS BEEN SUBJECTED TO HAS BEEN -23 DEG. CENTIGRADE. ONE PHENOMINA THAT I HAVE NOTED THAT DURING LONG PERIODS IN THE COLD THE WATCH TENDS TO GAIN MORE TIME THAN WHEN I AM CONFINED TO THE BASE. ( A DIFFERENTCE OF 3 SECONDS PER 24 HOURS GAIN )

THE LUMINOUS NUMERALS AND HANDS ARE EFFECTIVE AND EASY TO READ IN THE DARK, ESPECIALLY CONSIDERING THAT THE BASE IS 9 METRES BELOW THE ICE AND HAS DARK PASSAGES, ETC.

DUE TO THE GLARE OF THE SUN ON THE ICE, EVERYBODY WEARS SNOW GOGGLES (USUALLY POLARIZED) OF SOME SORT. EVEN THROUGH STRONG POLARIZED LENSES THE DIAL IS STILL EASY TO READ, AS APPOSEDOPPOSED TO SOME MAKES OF DIGITAL WATCHES THAT ARE UNREADABLE THROUGH POLARIZED LENSES.

ONE VERY IMPORTANT THING IS THAT I AM ALWAYS CONFIDENT OF HAVING THE CORRECT TIME TO CONDUCT MY READINGS AND TO HAVE DATA AVAILABLE ON SCHEDULED TIMES.

AS A MATTER OF INTEREST, ONE MEMBER OF THE OLD TEAM WHO HAS BEEN HERE FOR 14 MONTHS ALREADY, ALSO HAS A ROLEX EXPLORER WHICH IS 25 YEARS OLD AND STILL WORKING WELL.

REPORT ON ROLEX EXPLORER I

Thank you for your report dated the 2nd February 1987 a copy of which has been sent to Rolex Geneva.

When querying with our parent company in Geneva the reasons for the excessive gains made by your watch (2 minutes per 24 hours), they advised that it was probably due to the temperature effects on the lubricant within the watch. Apparently, on expeditions of this nature or on the Everest climbs, these watches are lubricated with a special fluid which obviates the particular problem which you experience.

By now you will have had your watch returned to you and we trust that it is performing satisfactorily. Please let me know if you require the regulation to be adjusted any further.

The public relations department of Rolex Geneva will be advising me in due course should they wish to use your report or any of the slides which you submitted to me for publication or advertising purposes. We will, of course, channel any request of this nature through yourself.

I am returning the slides to you as requested.

Dear Mr Haddon,

The German ice-breaker, Polar Stern, has been in close proximity to SANAE doing research work in the pack ice and they have taken the liberty to visit us here. So to make use of sending letters back to South Africa, I have taken this opportunity to write to you.

Firstly I would like to tell you more about the last few months here. The dark Antarctic night closed over us from the 25 May until the 23 July. During this period we experienced some of the lowest temperatures recorded over the last 6 years here, well into the minus 40's, Centigrade. These low temperatures took their toll on cameras and watches alike.


We have also been fortunate to see some amazing auroral displays - these usually on the coldest of nights, which makes photography difficult. This type of photography necessitates time exposures, and that is when my Rolex comes into a class of its own. In fact my Rolex has been the only watch to work satisfactorily at these low temperatures. The luminous numerals and hands makes it easy to do accurate time exposures during the photographic sessions in the cold.

Unfortunately one problem has arisen with the watch. From about the beginning of June the watch started gaining time, this being a considerable amount. Monitoring from two radio time signals in the base, the time gain is between 40 and 60 seconds per 24 hours. This is a slight problem as time marks on data recording apparatus need to be made daily. At present I only set the watch every 3rd day, but it will be inconvenient during the month of October when I will be away from the base. This however, will not be too serious, as I will not be doing accurate meteorological work at our Summer base.

Besides this small inaccuracy, the watch is extremely reliable and I am very grateful for it's use.

So far our return date has been set for the beginning of February, 1987. I will be contacting you soon after my arrival in Cape Town.

THE SUN HAS RECENTLY RETURNED TO US AFTER 2 MONTHS OF ANTARCTIC  
DARKNESS. DURING THE ANTARCTIC 'NIGHT' WE EXPERIENCED SOME OF  
THE COLDEST TEMPERATURES RECORDED HERE OVER THE LAST SIX YEARS.

Report on Rolex Explorer I

The report will be broken into 3 sections: a) the watch and its performance; b) the base and life at SANAE; c) details of the slides.

a) From the time I left Cape Town (3rd Jan 1986), I wore the watch until I returned to Cape Town on the 26th Jan 1987. During this period the watch was subjected to various conditions that may be expected in the Antarctic. These included low temperatures (down to minus 50 degrees Centigrade), a combination of shock/vibration with the cold, and long periods of being wet.

As far as cold temperatures are concerned, my Rolex was the only watch to operate at these temperatures. The Rolex came into a class of its own when photographing aurora during the cold winter nights. The watch was mounted on the tripod so that time exposures could be made. (Thanks to the excellent luminous numerals and hands accurate time exposures were possible.)

Unfortunately, the metal strap of the watch caused cold burns on my wrists on certain occasions.

However, as the year progressed, the watch gained more and more time, and by October the watch was gaining about 2 minutes per 24 hours (when fully wound). I also noted that when the watch was subjected to more movement, eg. when working outside, the watch gained more time than when I was confined to base and doing base work. This did, however, make certain of my meteorological work difficult as I had to make accurate time marks on some of the recorders.

Apart from the time gain, the watch never let me down and was a pleasure to wear.

b) SANAE is a buried base, and at present the base is about 14 metres below the ice surface. The base is constructed from ARMCO corrugated steel. It is situated about 13 km from the edge of the main ice shelf and is moving at approximately 60 metres a year towards the edge. The emergency base is a new design, built above the ice, and raised each year so that it stays about 8 metres above the ice.



The over-winter team consists of 15 men, while during the relief time (mid-summer), there are as many as 80 people. These include the new team, the base maintenance team, scientists, helicopter pilots and crew.

As a team we worked and lived in close proximity, learning about all the programs and base running. As a matter of interest, some of us suffered during the dark winter months from "mid winter insomnia", or as known to us as "big eye". The reason I mention this is that while suffering from "big eye", I sometimes did not sleep for 4 to 5 days, or slept at odd times and for varied lengths. At these times I did not know if it was AM or PM, or even the date. So if anyone should use a Rolex Explorer in these areas, I would recommend the Explorer II with the date and 24 hour hand, rather than the Explorer I.

c) I would appreciate it if the slides were returned to me as I have not made copies of these slides. Should you wish to copy or print any of the slides, I have indicated the make of film behind each description.
