Sir,

In reply to your letter No. 250189/11 of the 2nd instant, I am directed by Mr. Secretary Harcourt to state that he has no information with regard to the probability of a ship visiting Tristan da Cunha in the near future; but he does not suppose that it is at all likely that the Lords Commissioners of the Admiralty would be willing to send one of His Majesty's ships.

The Officer Administering the Government of the Union of South Africa was asked in a despatch dated the 23rd August last to request his Ministers to bear in mind the question of communication with Tristan da Cunha and to give the Secretary of State the earliest possible intimation of any opportunity of communication which may occur or be expected to occur.

Any such intimation would of course be at once communicated to the Postmaster General.
