
Under and by virtue of the powers vested in me by Section four of the Sea Fisheries Act, 1940 (Act No. 10 of 1940), I hereby declare that Proclamation No. 216 of 1946 as amended by Proclamations No. 343 of 1947 and No. 31 of 1948 is hereby further amended -

1. by the insertion in paragraph (2) after the word "except" of the words and figures "during the period from the 8th December, 1948, to the 7th April, 1949, both days inclusive and thereafter";
2. by the substitution in paragraph (3) of the figures "1949" for the figures "1948" wherever they appear in the said paragraph;
3. by the insertion in sub-paragraph (b)(vi) of paragraph (4) before the word "in" of the words and figures "except during the period from the 8th December, 1948, to the 7th April, 1949, both days inclusive".
